निर्देशित किया जाता है कि इस संबंध में तत्काल कार्यवाही आरंभ करें। मनरेगा ऑपरेशनल गाईड लाईन ड्राफ्ट 2012 के एनेक्सर ए—22 को इस संबंध में उपयोगिता प्रमाण—पत्र के रूप में उपयोग किया जा सकता है एवं इस प्रकार की राशि की वसूली का पृथक लेखांकन एवं रिजस्टर आदि संधारित करवाया जाये। इसी के साथ सनदी लेखाकार या अन्य किसी भी लेखा परीक्षा को इस कार्यवाही से निश्चित रूप से अवगत कराया जाये। इसी के साथ व्यवस्था सुनिश्चित की जानी है कि Misappropriation/embezzlement का कोई भी प्रकरण आपके जिले में उद्भृत न हो। जिले के आंतरिक लेखा परीक्षण दलों को आपके जिले में सिक्रय उत्तरदायित्व देकर इस प्रकार के प्रकरणों पर सूक्ष्म अनुश्रवण भी निरंतर करवाया जाये।

Subject: - Process for closure of complaints received under MGNREGA from various authorities regarding.

Sir/Madam,

Complaints received by the Ministry on irregularities in the implementation of MGNREGS in States are forwarded to State Governments for examination and furnishing adequate action taken reports. Further the release of funds to States is linked with resolution of complaints within a time frame. It has been observed that at times, due to lack of clarity about the action required to be taken. State Governments are under the impression that as they have submitted the ATR, the complaint shall be treated as closed. However, in MORD's record, it continues to be pending. This pendency of complaints sometimes leads to delay in release of funds to Concerned State District.

It is therefore clarified that in the Ministry following action is required to be completed for closure of a complaint involving misappropriation/embezzlement of funds. The following actions must be taken by the State Government before any complaint will be treated as closed in the Ministry for the purpose of release of funds:

(I) For Action required to be taken against delinquent employees:

· Formal initiation of departmental enquiry and

Lodging FIR against the delinquent officers(s) in case, prime facie, a criminal intent is apparent

Action should have been initiated to recover the amount misappropriated.

(II) For Elected Officials:

- Proceedings for disqualification/termination should have been initiated under the State PR Act; and
- Recovery of misappropriated agricunt should have been ordered by issue of a formal recovery certificate of written order following a due process, if recovery is due.

If actions as given above are reported and initiated by the State Government then the complaint will be treated as closed at our end unless for specific reasons. it is desired and considered necessary to follow up the progress in Administrative/Criminal proceedings that have been mitiated.

Further, the amounts recovered in recovery cases should be deposited in the State Employment Guarantee Fund or in the appropriate MGNREGA account. A proper account thereof should be maintained and shown in the relevant Utilization Certificate...

This issues with the approval of competent authority.
