Subject: Submission of Labour Budget under Mahatma Gandhi NREGA for the year 2010-11

Madam/Sir,

As per Chapter iv, para 14, sub section (6) of the NREGA Act, the DPC shall prepare in the month of December every year a Labour Budget(LB) in respect of his district for the next financial year. These LBs are required to be prepared in a bottom up approach by each GP which should be approved by the respective Gram Sabha. The procedure to be followed for preparation of LB is detailed at Chapter 8.4 of the Operational Guidelines. The proforma for preparation of LB in which it has to be sent to the Ministry is available on NREGA MIS. While preparing LB, it should be ensured that all the columns are duly filled in especially the month wise projection which is the only tool for the Ministry to assess demand of the district in advance with seasonality aspect while releasing central funds. Therefore, GP-wise online entry should be completed without delay for all the district of your State which has not been done so far.

2. This is an essential document that enables Ministry to assess the financial requirement of the district in advance and accordingly release first instalment during the financial year. It has to be ensured that LBs are prepared in harmony with Section 13,14,15 and 16 of the Mahatma Gandhi NREG Act and must have followed the principle of bottom up approach. Accordingly, the proceedings of each Gram Sabha in which respective LB and the shelf of projects have been approved have to uploaded as an attachment to the respective LB. The State Government would also be required to furnish a certificate to the effect that these sections(13 to 16) of the Act have been satisfied and a bottom up approach has been followed in preparation of LB for 2010-11 before the sitting of the Empowered Committee in the Ministry which is slated sometime in the third week of February 2010.

3. It is therefore requested to submit online the Labour Budgets for 2010-11 for each district of your State following above instructions without further delay.

4. This may be treated as most urgent.

Enclosure: Instructions to fill LB in the MIS

Labour Budget: MIS instructions:

1. LBs are to be filled in the NREGA MIS for the FY 2010-11. All the works with administrative and technical approvals are to be entered into the MIS.
2. While entering the details of the work "priority" as decided in the Gram sabha should be maintained even when selecting the works for the LB preparation.
3. ***Signed scanned copy of the minutes of Gram Sabha meeting held for the planning of works should be uploaded in to MIS while uploading the LB.***
4. In the data entry page there is a section "Labour Budget" which has two forms:
 - i. *Labour projections (Enclosed as Format-1)*
 - ii. *Work projections(Enclosed as Format-2)*
5. **Labour projection form:** Following information has to be filled:
 1. Projected Employment Demand for Next Year.
 2. Projected Persondays generated for Next Year.
 3. Projected Expenditure for Next Year (In lakh).
 4. Projected Families completing 100 days Next Year
6. **Work projection form:** Following information has to be filled:
 1. Total No. of Spill over Works from Previous year.
 2. Total No. of New Works Taken up in Current Year.
 3. No. of Works Likely to Spill Over From Current Financial Year to Next financial
 4. No. Of New Works Proposed for next financial year
 5. Volume/Area/ Distance unit ie benefit to be created.
 6. Persondays To be Generated
 7. Estimated Cost (RS. In Lakhs):-
 - On Unskilled Wage
 - On Material Including Skilled and Semiskilled Wages
7. *The Total Cost & Persondays to be generated should tally with the figures in the two formats mentioned above.*
8. *Submit the details of works with AS & TS which will be taken up in the next financial year in the given sample MIS work format (Format-3) given below.*
