The following clarifications are issued here with:

1. The contents of paragraph 3.1.2 (vii) (B) of Letter of Invitation (LOI) are replaced by the following:-

"Consultants/Registered firms/companies, in which the engineer retired from the Government service to the State of Madhya Pradesh or Chhattisgarh holds minimum 51 percent stake and possesses at least fifteen years experience in construction of road and bridge works, may be awarded consultancy services package(s) subject to the following:-

1.	Firms/Companies in which Executive Engineer have minimum stake of 51 percent.	Any sum of probable amount of construction work of consultancy services package(s) subject to award of maximum 2 package(s).
2.	Firms/Companies in which Superintending Engineer have minimum stake of 51 percent.	Any sum of probable amount of construction work of consultancy services package(s) subject to award of maximum 3 package(s).
3.	Firms/Companies in which Chief Engineer and above have minimum stake of 51 percent.	Any sum of probable amount of construction work of consultancy services package(s) subject to award of maximum 4 package(s).

The sentence "Consultants should submit CVs of the Team Leader and the Resident Engineer in the required number as per table-1 given in Para 5.3.1 of the Terms of Reference (TOR) along with the technical proposal. The CVs of TL/RE will be finalised after interviewing them" in paragraph 3 of Notice Inviting Offer is replaced by the following:-

"CVs of the Team Leader and the Resident Engineer in the required number as per table-1 given in Para 5.3.1 of the Terms of Reference (TOR) shall be approved before the agreement."

- 3. The word "year 2010-11" in the first line of paragraph 4.1.2 (iii) of Terms of Reference (TOR) and the words "up to 31st December 2010" in the last line of the same paragraph are replaced by "year 2012-13 (Third Phase)" and "up to 30th November 2012" respectively.
- 4. In paragraph 4.1.2 (ii) line 7 of Terms of Reference (TOR), the figure 6.00 is replaced by the figure 10.00.
- 5. The words "one per block" mentioned in S.No. 8 at Coloumn No. 3 of Table 2 in paragraph 5.3.1 of Terms of Reference (TOR) is replaced by "one per sub division of Rural Engineering Service"
- 6. The following is added to the SCHEDULE-E referred in paragraph 4.3 (ii) of Terms of Reference (TOR).
- (6) The letters of title "Mukhya Mantri Gram Sadak Yojna" shall be retro reflective.
- 7. The following is also added beyond what ever is added as per point 6 above.

Providing and fixing of typical MMGSY informatory sign board with Logo painting as per approved drawing. Made up of MS plates of 1.6 mm thick, top and middle plate duly welded with MS flat iron 25mm x 5m size on back on edges. The lower plate will be welded with MS angle iron frame of 25mm x 25mm x 5mm. The angle iron frame of the lower most plate and flat iron frame of middle plate will be welded to 2 nos. 75mm x 75 mm of 12 SWG sheet tubes posts duly embedded in cement concrete M-15 grade blocks of 450mm x 450mm x 600mm, 600mm below ground level. All M.S. will be stove enameled on both sides. Lettering and printing arrows, border etc. will be painted with ready mixed synthetic enamel paint of superior quality in required shade and colour.
